

History of Alzheimer's Disease Resource Center, Inc....

Founded in May of 1983, we are a non-profit, charitable tax-exempt organization dedicated to family service, education and research. ADRC currently advocates for over 60,000 individuals living on Long Island who have been diagnosed with Alzheimer's disease, as well as for their families and/or caregivers. Alzheimer's Disease Resource Center, Inc.(ADRC), **formerly known as the Alzheimer's Association Long Island Chapter**, separated from the National Alzheimer's Association in October 2012. Through an Arbitration process ADRC has been awarded all of its assets – tangible and intangible. ADRC continues to operate under its original Federal ID number and has been issued its own IRS Determination letter under that Federal ID number. ADRC's original NYS Articles of Incorporation have been amended to reflect our new name and ADRC continues to hold its original NYS Tax Exemption number.

In 2012 ADRC moved into a 9000 square foot building which houses the Mickey and Felice Neuwirth Care Center. The Center is currently under construction and when finished will include classrooms, a research library and an Adult Daycare program focused on individuals with Young Onset and Early Stage Alzheimer's Disease. We have constructed a beautiful Serenity Garden which has already proven its therapeutic value.

ADRC has also developed a number of training programs for professional caregivers, presentations for the community, and produces annually the ADRC Art Expression Program. The new Center also plays host to five Caregiver Support Groups and a Support Group for individuals with Young Onset Alzheimer's Disease.

Providing support, information and referral...

ADRC provides a broad range of programs and services for people with the disease, families, care partners, residential care professionals and professional health care providers. Highlights of our programs include the following:

Care & Consultation – provided through the Neuwirth Family Care Center, our Geriatric Care Manager consults with families developing long-term care plans and connecting families to available resources.

24 Hour On-Call Service – a toll-free service, available 24 hours a day, seven days a week, to families, health care professionals, and the general public across the country.

National Silver Alert® Program – provides vital information to law enforcement agents to assist in the search and safe recovery of individuals who have wandered and quickly reunite them with their loved ones. This program also provides medical information to emergency responders in the event that the PWAD cannot communicate verbally.

Education – more than 100,000 hours of education, service, and support programs including over 2500 hours of programs designed for individuals with dementia.

Support Groups – located in the New York Metropolitan area provide guidance and support for family caregivers.
